## **FY2011 HISTORIC PRESERVATION FUND GRANTS**



City of Abilene Historic Resource Survey Update Abilene, TX

CLG Grant Award: \$ 9,000.00 Total Project Cost: \$ 18,000.00

The City of Abilene requested CLG funding to complete an update of the city's existing Historic Resources Survey. The updated survey will document the current condition of existing historic and determine if additional properties are eligible for local, state and national designations.



City of Austin Public Property Inventory and Survey Project Austin, TX

CLG Grant Award: \$ 9,000.00 Total Project Cost: \$ 18,000.00


The City of Austin requested CLG funding to complete a comprehensive survey of all city owned properties exceeding 50 years of age to determine eligibility for local, state and national historic designation. The completed survey allows for proper treatment of city owned properties to preserve their historic character.



City of Dallas Landmark Commission Staff Assistance Dallas, TX

CLG Grant Award: \$25,000.00 Total Project Cost: \$50,000.00

The City of Dallas requested funds to support the existing city staff position tasked with assisting the City of Dallas Landmarks Commission. The staff person is integral to all historic preservation functions of the City, including Certificate of Appropriateness review, public education and Section 106 Review.



City of Galveston Historic Resources Survey Galveston, TX

CLG Grant Award: \$ 10,000.00 Total Project Cost: \$ 20,000.00

The City of Galveston utilized CLG grant funds to complete the City's Historic Resources Survey. Upon completion, the survey will document the historic resources of the island, creating opportunities for additional local, state and national designations. The integration of the survey data in to the city GIS system ensures the protection of properties from development and other threats.



City of Georgetown Historic Preservation Workshop Georgetown, TX

CLG Grant Award: \$ 12,473.00 Total Project Cost: \$ 24,946.00

The City of Georgetown requested CLG Grant funds to host a regional Historic Preservation Workshop in collaboration with the National Alliance of Preservation Commissions and the THC. The two day workshop used CLG funds to reduce the registration costs to allow CLGs throughout the region an opportunity to attend a NAPC training within the state.



City of Killeen National Register Historic District Nomination Killeen, TX

CLG Grant Award: \$7,131.00

The 2008 Killeen Historic Resources Survey identified a potential National Register District within the city's central business district. The City of Killeen contracted with a historic preservation consultant to prepare the National Register Nomination for the Killeen Historic Business District. CLG funds were used to develop the nomination for presentation to the State Board of Review.

Total Project Cost: \$ 14,262.00



City of Killeen Historical Outreach Video Project Killeen, TX

CLG Grant Award: \$ 12,500.00 Total Project Cost: \$ 25,000.00

The City of Killeen identified a need for education and outreach materials to continue to tell the story of Killeen's historic resources. Through the CLG grant, Killeen contracted with a video production company to develop a series of community outreach videos detailing the rich history of the community. Research conducted for the 2008 Survey and NR Nominations was incorporated in to the videos.



City of McAllen Historical Resources Survey Phase II McAllen, TX

CLG Grant Award: \$ 22,500.00 Total Project Cost: \$ 45,000.00

The City of McAllen initiated a Historic Resources Survey in 2005. In 2011, the city requested CLG funds to begin Phase II of the survey project. The survey includes detailed information on the 1,655 historic structures located within the survey boundaries and will be utilized to develop National Register nominations.



City of Nacogdoches Historic Resources Survey Update Nacogdoches, TX

CLG Grant Award: \$ 9,022.00 Total Project Cost: \$ 18,044.00

The City of Nacogdoches collaborated with Stephen F. Austin State University to complete an updated historic resources survey focusing on the historic core of the city. The City utilized CLG funds to purchase GPS based survey equipment to conduct the survey. This updated survey may result increased opportunity for economic revitalization and interpretation of historic resources.



City of Round Rock Downtown Historic Preservation Master Plan Round Rock, TX

CLG Grant Award: \$ 10,000.00 Total Project Cost: \$ 20,000.00

The City of Round Rock adopted the Downtown Master Plan in 2010. In order to implement the plan, CLG funds were utilized to develop a preservation plan to protect and utilize the existing historic resources. Phase I was completed and adopted by City Council in late 2010 with Phase1B and II scheduled for adoption in 2012.



Travis County Webberville Corridor Cultural Resources Survey Travis County, TX

CLG Grant Award: \$4,964.50 Total Project Cost: \$13,000.00

Travis County undertook a multiphase Cultural Resources Survey in 2004, focusing on the unincorporated areas of the county. The FY 2011 CLG Grant provided funding for the fourth phase, focusing on the Webberville Corridor in Eastern Travis County. Once all phases are completed, the survey will document the resources of the county currently threatened by development pressures as the Austin area continues to grow.
