- V. Review of Nominations for the National Register of Historic Places:
 1. Killeen Downtown Historic District, Killeen, Bell County

Killeen primarily served as a center of regional agriculture until nearby Camp Hood became a major training ground for U.S. soldiers during World War II. The city population increased tremendously after the camp was re-commissioned as a permanent fort in 1950, sparking new growth in the central business district.
 2. Pittsburg Commercial Historic District, Pittsburg, Camp County

The Pittsburg Commercial Historic District contains a high concentration of properties that reflect the town's turn-of-the-century evolution from a small rural outpost to a thriving center for agricultural packing, shipping, and manufacturing.
 3. Dripping Springs Downtown Historic District, Dripping Springs, Hays County

Largely constructed of native stone, the small-scale domestic, commercial, civic, and industrial buildings clustered along Mercer Street are reminders of Dripping Springs' simultaneous role as an agricultural hub for the surrounding area and as tourist stop-off point along an early major highway.
 4. Mineola Downtown Historic District, Mineola, Wood County

Mineola was established as a railroad town with subsequent development strongly influenced by the alignment of the tracks. Its downtown district has served as the city's commercial and civic focal point, as well as a regional commercial center for well over a century.

5. Old Spanish Trail from U.S. 90 to I-10, Columbus, Colorado County

Built in 1920-21, this narrow concrete and asphalt road served as a segment of the primary automobile route between Houston and San Antonio, and as part of a transcontinental highway connecting St. Augustine, Florida, with San Diego, California.
